**LAST CHANCE "B" FEATURE (if needed):** 1st- \$300; 2nd-\$250; 3rd-\$200; 4th-\$190; 5th-\$180; 6th-\$175; 7th-\$170; 8th-\$165; 9th-\$160; 10th-\$155; 11-\$150; 12th-\$150; 13th-\$150; 14th-\$150; 15th-\$150;

**NHMS AWARD:** Winner will receive \$500 bonus for qualifying for the 9th Annual ACT Invitational at New Hampshire Motor Speedway. If a previous 2017 NHMS Award recipient wins the event, the bonus will go to the highest-finishing driver who has not received an NHMS Award in 2017. Bonus is contingent upon timely entering and participating in the ACT Invitational. Competitors must be ACT approved to compete at NHMS.

**ACT 100%ers:** 100% status will be awarded to registered owners of assigned car number (if no owner's license is purchased for the car number then the driver is considered the owner). If positions are added beyond those posted on the entry and an ACT 100%er finishes in one of those positions then they will be guaranteed the posted last place money on the entry form.

**Year end point fund will ONLY be paid out to registered car owners (or drivers if no owner is registered) who are 100% participants for the entire season.** Under 2017 ACT provisional procedure if only a single (1) 100% competitor is not qualified through normal qualifying procedure, that competitor will be awarded an extra provisional starting spot.

**Thunder Road 100%ers:** If necessary, one provisional will be awarded to a Thunder Road regular competitor who has participated in 100% of the Thunder Road championship point-counting events in 2017.

**Feature event is 200 laps.** ACT reserves the right to modify qualifying and race procedures according to number of cars in attendance, and other relative conditions.

**\$50 Entry Fee** for all cars payable with coupon unless full season entry has been filed.
