

# 2024 ACT TOUR (U.S.) FULL SEASON ENTRY

The undersigned ACT licensed driver and/or car owner wishes to enter all 13 2024 American-Canadian Tour point-counting events. Enclosed is a check in the amount of \$700 U.S. (a savings of \$275 from the timely submission of individual entries) if received/postmarked on or before **March 1, 2024**. After **March 1, 2024**, the full-season entry price will be \$1000. I/we understand this entry fee is not refundable in whole or in part. Furthermore, if any races are added to the ACT Tour, this full-season entry will cover those events.
