VP RACING FUELS HARD CHARGER AWARD: A certificate for a 5-gallon pail of VP “spec” fuel will be awarded to approved VP Hard Charger who gains the most positions relative to their starting position during the feature event contingent upon proper display of decal.

VP RACING FUELS POLESITTER AWARD: A certificate for a 5-gallon pail of VP “spec” fuel will be awarded to driver who earns the 1st starting position for the feature event during qualifying contingent upon proper display of decal.

DRP AWARD: Details to be announced.

GENERAL PROCEDURES: Feature event will be 65 laps. Field will be set from heats and “B” feature (if needed). Qualifying procedures will be announced at Drivers Meeting. ACT reserves the right to modify qualifying procedures based on number of cars in attendance. Rules and procedures will be determined by ACT rule books and manuals. In case of early termination of the event due to rain, etc., the race will be official when 33 laps have been completed.
